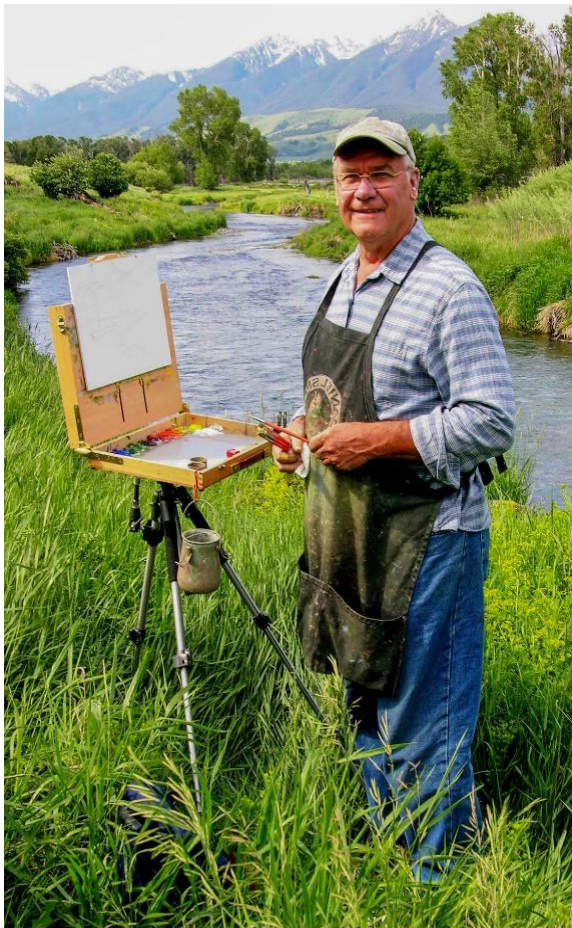


## AIS 2020 ONLINE EXHIBITION
